



AviLighting™ Limited Warranty

Thank you for your interest in the products and services of AHPharma Energy Systems, Inc.

This Limited Warranty applies only to physical goods of the AviLighting™ line of products purchased from AHPharma Energy Systems, Inc. (hereby referred to as “physical goods” and “product”).

What does this limited warranty cover?

This Limited Warranty covers any defects in material or workmanship under normal use during the Warranty Period.

During the Warranty Period, AHPharma Energy Systems, Inc. will repair or replace, at no charge, products or parts of a product that proves defective because of improper material or workmanship, under normal use and maintenance.

What will we do to correct problems?

AHPharma Energy Systems, Inc. will repair the product at no charge, using new or refurbished replacement parts.

How long does the coverage last?

The Warranty Period for physical goods purchased from AHPharma Energy Systems, Inc. is 5 years from the date of purchase. Coverage terminates if you sell or otherwise transfer the product.

A replacement product or part assumes the remaining warranty of the original physical good and does not receive a new 5 year warranty.

What does this limited warranty not cover?

This Limited Warranty does not cover any problem that is caused by:

- Conditions, malfunctions or damage not resulting from defects in material or workmanship
- Selling, or otherwise transfer, of product to another person and/or entity
- Negligence of use, or misuse of product other than for intended purpose
- Theft
- Acts of God, such as hurricanes and floods
- Improper washing procedures
- Submersion in water or other liquids
- Crushing or trampling of the fixture
- Exposure to environmental factors not typical in a poultry rearing facility
- Improper installation (not in accordance with installation instructions provided with your physical goods)

AHPharma Energy Systems, Inc. reserves the right to forgo fulfillment of the limited warranty if the physical goods are defective due to any reason other than improper material or workmanship, under



normal use and maintenance. AHPharma Energy Systems, Inc. also reserves the right to inspect returned products and determine what defects are due to improper material or workmanship.

How to get service

To obtain warranty service, you must first contact us to determine the problem and receive further instructions on how to proceed. If the product became defective under normal use and maintenance, we will send you a package with pre-paid shipping included. You will then use this package to send the physical goods to the manufacturer for repair/replacement. Upon review and inspection of the returned product, AHPharma Energy Systems, Inc. will determine whether the defect is covered under the terms of this limited warranty and respond with said information. If the product is defective due to improper material or workmanship, the product will be repaired or replaced. Once repaired or replaced, the product will be shipped back to you directly at the cost of the manufacturer.
